About Pledges

1. A pledge is a commitment to pay a certain periodic sum (whether monthly, quarterly or annually) over a period of years. Its value to The BRIT School Foundation is that it enables us to plan income to the Campaign with a degree of certainty.
2. A Limited Liability Company pays the total (gross) donation to the Foundation over four years. The total annual amount of the pledge can then be set against pre-tax profits when calculating corporation tax liability. Therefore when a Limited Liability Company makes a pledge to a charity, the value of this pledge is much greater than the net cost to the company.
3. For example, if a company paying 20%* corporation tax makes a donation of £10,000 to the Campaign, it can set this against corporation tax. The company saves £2,000 in corporation tax and the net cost of the donation is therefore £8,000.

* The Main Rate applied from April 2015. Tax rates are subject to change.
